- Go to www.irs.gov. On the home page, click on "Get Your Tax Record." Click "Get Transcript by Mail." Be sure to request the "IRS Tax Return Transcript" and NOT the "IRS Tax Account Transcript."
- Online Go to www.irs.gov. On the home page, click on "Get Your Tax Record." Click "Get Transcript Online." Again, be sure to request the "IRS Tax Return Transcript" and NOT the "IRS Tax Account Transcript."
